Further to our letter No.BT/BM-1/3346 dated 14.03.2023 (copy enclosed) regarding timely registration of contracts of apprentices under National Apprenticeship Training Scheme (NATS), it is observed that few establishments are still failing/delaying in registration of contracts of Apprentices on national portal www.mhrdnats.gov.in and are under category of non-complying establishment in our record.

It is therefore, requested to stick to following timeline for the compliance of the Apprentices Act:

Respected Sir/ Madam,

As you are aware, this Board implements National Apprenticeship Training Scheme (NATS) under the Apprentices Act, 1961, as amended in 1973 and thereafter, for Degree & Diploma holders in Engineering / Technology / Pharmacy / Architecture / Hotel management and Catering Technology / Library Science / Agriculture / Dairy / Biotechnology / Biomedical / Environment / Food Technology / Fashion Technology / Modern Office Management / Secretarial Practice/ many more as prescribed in the Apprentices Act and the Apprenticeship Rules. Further, the Board, w.e.f. December 2021, has also been mandated to implement apprenticeship training for Graduates (Bachelor) in general streams such as Arts, Science, Commerce, Computer Application, Business Administration, Hotel Management, Fashion Designing, Management Science, Fine Arts, Event Management, Journalism and Mass Communication, Social Work, Business Studies, Travel and Tourism Management, Design, Performing Arts etc.

As per the Act, the engagement of apprentices is obligatory for the establishments having manpower (regular and contractual employees combined) of 30 and more. Within a financial year, each establishment shall engage apprentices in a band of 2.5 % to 15 % of the total manpower strength of the establishment including contractual employees. Also, a contract is required to be registered within 7 days of engagement of each apprentice. For establishment having manpower of 4 to 29, apprentice engagement is optional.

It has been observed that few establishments do not engage the Apprentices and few others though engage Apprentices but fail/delay in the registration of Contract of Apprentices on the national portal www.mhrdnats.gov.in meant for this purpose. This causes inconvenience to the trainees (as they do not get certificate from Board) and the establishment fails in compliance of the Act. It causes revenue loss to the establishments at one hand and non-compliance at the other.

It is therefore, requested that timely registration of contract on the said national portal be ensured after engagement of apprentices. Those establishments not engaging apprentices may begin engaging apprentices to be part of national mission of skilling India.
